

- 2nd NBC Workshop to be held in Delhi.
- Recognition of the glass processing industry by various bodies.

ACTIVITIES DONE IN THE YEAR 2018

- 15 Management Committee meeting were held during the year to take forward the tasks undertaken.
- FOSG initiated the formation of Glass & Glazing Knowledge forum with one representative from each Float manufacturer, related Associations including FOSG. Mr. Sharanjit Singh representing FOSG was appointed as convener.
- Eight Glass & Glazing Knowledge Forum meetings were conducted. Six leading Architectural Institutes were identified in six different cities Delhi, Mumbai, Bangalore, Chennai, Hyderabad and Kolkata for conducting NBC workshops. The workshop in each city will be held in association with the respective city municipal Corporation.
- A hand book on National Building Code 2016 has been developed for the 12 workshops in six selected cities.
- Three days live-in training program was conducted from 1st to 3rd February 2018 at IIT Madras wherein 44 professors from leading architectural colleges from different cities attended. The attendees were trained to conduct NBC workshops in their respective institutes in association with the city Municipal Corporations.

- FOSG was represented in all the four BIS meetings to get the IS 2553 codes revised, the same was finalized and finally approved from BIS in their final meeting in Kolkata held on 12th January 2018.
- FOSG submitted representation with the department of Industrial policy & promotion and succeeded in convincing them to bring processed glass along with float glass under QCO simultaneously.
- FOSG submitted a representation to the GST council for reduction of GST from 28% to 18%.
- FOSG & Zak signed an MOU as strategic partners for 7 years with a substantial financial advantage to FOSG. Zak provided space to build Glass Experience Zone and a fully furnished FOSG lounge during the Zak Glasstech Expo in Mumbai from 7th to 10th December 2017.
- FOSG filed representation with Department of Industrial Policy & Promotion to exclude glass of thickness 15mm, 19mm, 25mm and Low iron extra clear glass from the QCO as they are not manufactured in India.
- Mr. Sharanjit Singh, member FOSG as convener of BIS CHD10:4 (subcommittee for processed glass) represented all the BIS meetings to develop separate codes for Low iron extra clear glass used for solar applications to come under IS 2553 (part 3).
- FOSG submitted representation with Laghu Bharti Udyog and Swadeshi Jagran Manch opposing the Governments order for reducing the custom duty on imports of safety glass from China.

- Mr. Gurmeet S Singh, Chairman, FOSG attended the meeting at Department of Commerce under the chairmanship of Mr. Shyamal Misra, Joint Secretary, opposing the order of the Government for the reduction of duty on imports of safety glass from China.
- Delegation spear headed by FOSG met Mr. Hardeep Singh Puri, Hon'ble Minister of Housing & Urban Affairs, for speedy implementation of National Building Codes (NBC) 2016.
- FOSG appoints Mr. Yogesh KT, of Aleph India QMS, on its panel to guide members for getting BIS certification.
- Mr. Gurmeet S Singh, Chairman, FOSG attended the meeting on Strategic Alliance for WTO & Trade Remedies Low Practice held at Hotel Le Meridian, New Delhi on 19th November 2018. The occasion was graced by Mr. Suresh Prabhu, Hon'ble Minister of Commerce & Industry.



FOSG Annual General Meeting 2018

The Annual General Meeting 2018 of FOSG was conducted on 11th August 2018 in The Muse Sarovar Portico, New Delhi under the chairmanship of Mr. Gurmeet S Singh. The meeting agenda comprised of adopting of annual accounts FY 2017-18, appointing of auditors for the FY 2018-19 and fixing their remuneration, Electing members for the new management committee for the FY 2018-19. The new management committee elected is a combination of young and senior members. This combination will see FOSG progressing rapidly.



The following points were discussed and decided.

- The Accounts FY 2017-18 were adopted.
- Auditors for the FY 2018-19 appointed and remuneration fixed.
- New Management Committee for the FY 2018-19 elected.
- FOSG to appoint one technical person to help members for the BIS certification.
- FOSG to appoint one commercial person to carry out and help members for the pool purchases etc.
- FOSG to have its own office.
- Broad discussion on the venue for the 9th Annual Processors Conclave 2019.

FOSG GOA Conclave (8th Annual Conclave Year 2018)

The Conclave was held at Bogmallo Beach Resort, Goa from 25th to 27thFebruary 2018, under the chairmanship of Mr. Gurmeet S Singh. The event was anchored by two young dynamic members Mr. Ali Kamil and Ms. Varsha Konidala. The conclave was attended by around 190 participants.

Glass processing Industry is primarily a family business enterprise. Indian Global effort need to bring professionalism and improve management skill of the entrepreneurs. With this objective in view the conclave objective was skill knowledge improvement and bv arranging Panel Discussions, Workshops and Professional Presentation by industry Professionals and consultants followed by Gala cocktail dinner on both nights. All



these activities were highly appreciated by the participants.

Welcome Address by Mr.Gurmeet S. Singh, Chairman FOSG

Mr. Gurmeet S. Singh, in his speech welcomed members and thanked sponsors for their continuous support and cooperation for their participation in Annual Processor Conclave 2018-19.

He was overwhelmed with the record breaking attendance and emphasized on the maximum numbers of new processors joining as members during the year.

Through his presentation he briefed members of the various tasks under taken and accomplished and specially emphasized on several meetings done with BIS for the modification and setting of standards/Codes for safety glass, meeting with officials from Department of Industrial Policy & Promotion and convinced them to release Quality Control Order (QCO) for both Float glass & Safety



glass simultaneously. He also briefed members on the Formation of Glass & Glazing Knowledge Forum, wherein one member from each float manufacturer, glass and glass related associations such as FOSG, GSI, Glass Academy, UWDMA and IFF are working together for the implementation of National Building Codes (NBC) through conducting NBC Workshops.

He reiterated that FOSG has made considerable progress during the year, this is an endless journey and one must continuously keep improving and aspire to achieve more. He solicited continued participation, co-operation and support from all the members to accomplish the desired goals.

At the end he thanked all the sponsors and members for their support extended to make this event a success.

Topic: Future FOSG, Where and how do we want to see FOSG in 2023.Vision, challenges and opportunities, Steps needed to move in the chosen direction and likely hurdles.

Observations

All the panelists were of the opinion that FOSG is not a need but a necessity. Many members offered to participate more actively and contribute to the needs of the community. It was noted that the members were shy in coming forward it was explained that the number of processors are increasing day by day and to cater the varied needs everyone has a right to give his views which could be different but once a final view is taken one should forget individual views and collectively follow the democratic decision. It was also suggested that the young processors should now be encouraged to come forward and participate more actively.



Topic: New processors and one plant processors. Their concerns, aspirations and expectations from FOSG. How to increase their participation and involvement.

Observations

It was noted that small or one plant processors are generally regional players and are shy of coming to FOSG. Some of them join but do not stay on or lose interest. The panel discussed the needs and the conclusion was that the organization structure of FOSG needs to be reviewed to cater to regional or cluster meets and the concept of cluster membership should also be explored.

Topic: Inventory sharing and pool purchase. Benefits, modalities, communications, information exchange and safeguards. What's App and associated problems. FOSG website and associated doubts or apprehensions.

Mr. Sharanjit Singh informed members that we have tried the benefits of sharing information through an excellent tool in the form of our website and mobile App. The inventory sharing wherein excess inventory with one fulfilled the need/requirement of the other was successfully tried and achieved great success. He emphasized that the benefit of the App would have been much more if the forum was used more frequently and with more members. Some pool purchases have also been successfully done with cost reduction. He requested all the members to start using the mobile App more frequently instead of the what's App group for needs or give always. All the panelists concluded that a new thrust should be made to popularize FOSG website and mobile App and requested those members who still not have downloaded the App to download the same and share E-mail ID with Mr. VinodTandon for registration.

Topic: QCO: Law of compulsory marking of BIS on Float and Processed glasses, impact on imports. What about items not made in India like extra clear and 19mm glasses, new opportunities and challenges.

Observations

This was a very important discussion as the QCO on float and processed glass, was to change the way we carry out our businesses. In this panel of discussion the panelists discussed the pros and cons of the upcoming mandatory BIS law of marking and came to a conclusion that it would be beneficial for all processors as it would make them more quality conscious and could gain customer confidence/satisfaction on assured quality products.

Observations

As all the processors have float manufacturers as main suppliers and ideally should have a customer supplier relationship but some of the panelists were totally or almost fully aligned with some float makers and some were highly critical of some or all float makers while a vast number were neutral or silent. There were no problems noticed in relationship with customers. The panelists felt that there was a need to improve relation between float and processors and expected respect and consideration for which they suggested to have frequent communications with float manufacturers for improving the current deficit in relationship.

There was another problem addressed of shortage of small quantities of left over quantities towards the completion of a project. The issue was suggested to be resolved by float glass agreeing to make small quantity supplies and processors helping each other by inventory sharing system.

Topic: National Building Codes, RERA: impact on our market. Education and awareness initiatives for its effective implementation. Steps taken so far and what further needs to be done.

Observations

Mr. Sharanjit Singh informed members that the NBC and RERA can give exponential growth to the processed glass consumption provided there are steps taken by the industry for education, awareness and enforcement. The panelists appreciated the steps taken by FOSG to create Glass & Glazing Knowledge Forum (GGKF) by bringing all the glass and glazing related associations and all float makers on one platform to plan and implement the education and awareness initiatives and to fund it adequately.

As a first step, a three days 'Train the Trainers' workshop on use of Glass & Glazing Systems in Indian Buildings as per National Building Codes 2016 was organized from 1st to 3rdfebruary 2018 at IIT Madras, Chennai. The workshop was well attended by 44 professors and scientists from 16 prominent academic institutions in India including SPA, Delhi, Academy of Architecture, Mumbai, Sir JJ College of Architecture, Mumbai, Jadhavpur University, Kolkata, Anna University, Chennai, SAP, Chennai, MS Ramaiah Institute of Technology, Bangalore, CSIR-CGCRI, Kolkata, Manipal Institute of Technology, LS Raheja School of Architecture, Mumbai, Sidhaganga Institute of technology and Lal Bahdur Shastri Rashtriya Sanskrit Vidyapeeth.

Some of the trained professors from the above institutes will be the master trainers and conduct workshops for practicing Architects, Structural Engineers and Corporation Engineers for awareness and education.

All panelists appreciated the efforts taken by FOSG for spreading awareness for the implementation of NBC and suggested that teaching and making their own marketing staff aware was also necessary and FOSG will plan for the same in the near future.

Mr. Vipul Chauhan, from Creatif Technologies gave a detailed presentation and briefed members through a demo of their software which would help every processor to work more systematically and comfortably.



How To Review, Reduce & Recover Prevalent Practices, Norms & Improvement For Future

Mr. Tariq Kachwala through a very informative presentation briefed members on manufacturing & post manufacturing costs & advised members how they need to get educated upon the manufacturing as well as post manufacturing costs such as packaging, unloading, documentation etc. which most of the processors may not be evaluating. He further recommended that processes should calculate their individual costs & try to review, reduce& recover.

FOSG Part Of The Press Meet Of Laghu Udyog Bharti & Swadeshi Jagran Manch

FOSG represented by Mr. Gurmeet S Singh and Mr. Vinod Tandon was part of the press meet organized by the Laghu Udyog Bharti & Swadeshi Jagran Manch against the Governments change of definition for MSME's under the presidentship of Dr. Murli Manohar Joshi, member Lok Sabha and former cabinet minister and supported by Dr. Ashwini Mahajan, Swadeshi Jagran Manch and Mr. Jitendra Gupat, Laghu Udyog Bharti.



FOSG put forward their concern regarding the reduction of custom duty on imports of safety glass from China. FOSG strongly opposed the order and in its representation informed that there are over 200 Glass processors across India which mostly comes under micro & small sectors producing processed glass and providing employment to over 25,000 people. The duty has been reduced by 5% on toughened glass and 30% on insulated glass on imports from China while

there is anti dumping duty on imports of float glass which is our raw material and is made by large industrial giants. It also stated that the Governments move on reduction of duty was unfair, unjust, unrealistic and totally against the interest of the domestic MSME's and the principle of Make in India. This move from the Government will further bring down the capacity utilization and lead to units becoming sick and shutting down creating huge unemployment and bank defaults.

This unprecedented move from the Government at one side putting restriction on imports of raw materials and on the other hand the value added finished goods are given a duty concession on the same product from countries which are known for dumping of goods manufactured by Indian MSME's.

FOSG submitted representation to Laghu Udyog Bharti strongly opposing to the duty concession



being given to the Chinese companies and with request to withdraw the duty concession to help domestic MSME's survive.



1st NBC Workshop- Glass & Glazing Aspects

Glazing Society of India (GSI) jointly with BIS and IIT Madras organized the first NBC workshop-Glass & Glazing Aspects in Mumbai at L.S. Raheja School of Architecture on 3rd of August 2018. The Workshop was supported by Federation of Safety Glass, All India Glass Manufacturers Federation, Confederation of Construction Products & Services, International Fenestration Forum, Glass Academy, UPVC Windows and Doors Manufacturers Association and L. S. Raheja School of Architecture.

The objective of this workshop was to sensitize the entire construction value chain on the codes and provisions given in NBC 2016 on the use of glass and glazing systems in Indian Buildings and thereby enabling the implementation of the same.

Total 180 (Approx.) participants comprising of professionals like Architects, Builders, Consultants, Civil & Structural engineers, Government professionals, processors, manufacturers and other experts participated. The workshop had three technical sessions comprising of seven technical presentations. Speakers for each presentation were experts from BIS, IIT Madras, MIDC Industry and members of NBC panel.

The workshop covered the following sections in NBC 2016:

- New Section for Structural Glass and Glazing Systems in the Part 6 Structural Design as per Section 8 'Glass and Glazing' covering selection of materials, energy and light, fire and loading and safety to human impact and installation of glazing systems in buildings.
- New chapter Part 11 'Approach to Sustainability', which deals with different aspects of building planning, design including envelope optimization, material selection, construction, services, operation and maintenance having impact on sustainability.
- ➤ Fire and Life Safety related to glass and glazing aspect as per part 4 in NBC: 2016.

Mr. S. Arun Kumar, Scientist D, Civil engineering department, BIS gave presentation on the overview of NBC 2016.

Mr. R.N. Dandekar, Convener, panel for Glass & Glazing of NBC 2016 gave presentation on overview of Glass & Glazing codes in building construction.

Prof. S. Arul Jayachandran, member, panel for Glass & Glazing of NBC 2016 gave presentation on structural design and selection of Glazing system..

Mr. Amar Kool, member, panel for sustainability of NBC 2016 gave presentation on approach to sustainability including envelop optimization.

Mr. S.S. Warrick, member, panel for fire protection of NBC 2016 gave presentation on fire and life safety.

Mr. Antony John, member, panel for Glass & Glazing of NBC 2016 gave presentation on Glass façade system, criteria, fabrication, installation and testing.

Mr. Sharanjit Singh, member glass, Glassware and Laboratory wares technical committee of BIS. Gave presentation on Glass in buildings, quality requirements & human impact safety.

After the grand success of the 1st NBC workshop in Mumbai, Glass & Glazing Knowledge Forum in its 7th meeting held on 11th August 2018 has decided to conduct a bigger 2nd NBC workshop in Delhi in the month of October 2018.

Training the Trainers program.

Three days live in training the trainers program held in IIT, Madras, Chennai from 1st to 3rd February 2018. The three days live in workshop was supported by Bureau of Indian Standards (BIS), Federation of Safety Glass (FOSG), All India Glass manufacturer Federation (AIGMF), Confederation of Construction Products & Services (CCPS), Glass Academy, International Fenestration Forum (IFF) and UPVC Windows and Door Manufacturers Association (UWDMA).

The workshop had theory sessions, case studies, demo sessions and plant visits covering all aspects of the use of Glass & Glazing Systems in buildings including Energy Efficiency, Safety, Structural Integrity and others as per NBC 2016.

The workshop was addressed by 15 eminent speakers from industry and Academia including Mr. Arun Kumar, Scientist E, BIS, Mr. Sharanjit Singh, Chairman, GSC Glass Ltd., Mr. Mahesh Arumugam, Director, Meinhardt Façade Technology, Ms. Deepa Sathiram, Director, EN3, Mr. Antony John, Technical Director, Schueco India, Ar. Deepak Gahlowt, Director, Xebec Design, Mr. Ravishankar, Technical head, Dow Corning, Mr. N. Murali,



head-Design and sustainability, Saint Gobain India, Ar. Adity Salway, Technical Expert, AIS, Mr. Sudhir Mohan, Technical Expert, Gujrat Guardian Ltd., Mr. Jothiramalingam, Director, Winwall Technology and others.



The event had three exclusive live demos by the Structural Glass Research and Testing (SGRT) Facility, Winwall Technology, Dow India, Schueco India and UWDMA. The participants visited three plants on the second day Saint Gobain India, FUSO Glass and Shobha Glazing and Metal Works.

The workshop was well attended by 44 faculty members from 16 Architectural and Engineering

academic institutions including SPA Delhi, Sir JJ School of Architecture, SAP Chennai, IIEST, Jadhavpur University, CSIR-CGCRI, Ramaiah Institute of Technology etc.

The workshop was conducted as a part of creating a group of trainers for training the construction professionals on National Building Code 2016 through a series of workshops at the respective academic institutions participated in the event.

All the participants were awarded a certificate of participation jointly from IIT, Madras and GSI.

Report of QCO on Transparent Float Glass IS 14900 & Safety Glass IS 2553

FOSG represented by Mr. Sharanjit Singh and Mr. Gurmeet S Singh was once again responsible to bring QCO on safety glass through several meetings with DIPP and one to one meeting with the Joint Secretary, DIPP. The Department of Industrial Policy & Promotion issued QCO (Quality Control Order) on transparent float Glass IS 14900. FOSG intervened and filed representation opposing the QCO and had many joint and one to one meeting with the department. The department expressed inability to withdraw the order to which FOSG after discussion convinced the department to also issue QCO on Safety Glass IS 2553 and not only issue but requested that both the QCO's on Float Glass & Safety Glass should be issued simultaneously which the department agreed. FOSG also appealed through representation to exclude glass of thickness 15mm, 19mm, 25mm and low iron extra clear glass for the QCO since they were not manufactured in India which was denied but alternatively suggested to get new separate codes made for low iron glass so that it could be treated as different from IS 14900 which is float glass. Both the QCO on Float Glass and Safety glass has now been cleared by the Government and QCO on float glass has already been uploaded in the WTO website and QCO on safety glass is all set to be uploaded in the WTO website. The separate code for the Low iron glass for Solar application is also clear from BIS and is under circulation for comments and will come under IS 2553 (part 3). FOSG represented by Mr. Gurmeet S Singh, Mr. Sharanjit Singh and Mr. Vinod Tandon attended the last DIPP meeting held on 1st November 2018 under the chairmanship of Mr. Atul Chaturvedi, Addl. Secretary, for the finalization of QCO on Float glass, Transparent sheet glass and Safety glass wherein lot of pressure was put to implement QCO on Float and Transparent sheet glass and QCO on Safety glass can follow later. FOSG strongly opposed to it and finally it was assured that QCO on all three will be implemented simultaneously and will be enforced from 1st July 2019.

BIS CHD 10:4 (Subcommittee for Processed Glass) & CHD 10:6 (Subcommittee for Float Glass)

FOSG represented by Mr. Sharanjit Singh Convener BIS CHD 10:4 and Mr. Gurmeet S Singh attended all the BIS meetings held so far. After the clearance of IS 2553 (Part 1 & 2) BIS CHD10:4 (subcommittee for processed glass) met on 25th June 2018 to discuss and develop a separate code for Low Iron Glass for Solar application. After discussion and lot of deliberation and with the consent of all the standards were finalized and is now under circulation to members for comments. It was



decided there should be three parts of IS 2553 part 1 to cover Architectural Glass general applications, part 2 will cover Automotive glass and part 3 to cover glass for solar applications. BIS CHD10:6 (subcommittee for float glass) met on 18th July 2018 to discuss and develop codes for Low iron float glass. BIS standards for extra clear float glass has been finalized and cleared by BIS CHD10:6 on the same day with consent of all the members present. Separate code for textured glass was also discussed and awaits data/comments from some members before finalization.

FOSG delegation meets Mr. Hardeep Singh Puri, Hon'ble Minister, Housing & Urban Affairs, for the Implementation of National Building Codes.

FOSG, besides filing of RTI's with all the municipal corporations regarding the implementation of National Building Codes 2016, moves a step ahead and succeeds in getting an appointment with Mr. Hardeep Singh Puri, Hon'ble Minister for Housing and Urban Affairs, on the way forward for the enforcement of National Building Codes 2016 nationwide in the interest of the consumer and the industry. A five member delegation comprising of Mr. Gurmeet S Singh, Mr. Sharanjit Singh, Mr. Vivek Dubey,



Mr. R. Subramanian and Mr. Vinit Kapur met the minister on17th October 2018. FOSG submitted a written representation to the Minister with the following concerns.

- 1. Lack of awareness on the new inclusion of glass and glazing section in NBC 2016 amongst the municipal corporations.
- 2. Lack of understanding amongst the municipal corporations and their empanelled professionals on the various technological aspects on the use of safety glass in buildings.
- 3. The need to educate the empanelled architects / structural engineers / civil engineers.
- 4. The need to create the awareness and capabilities within the builders & developers community.
- 5. Monitoring and compliance mechanism for the use of safety glass in Indian Buildings.

Support requested from the Hon'ble Minister:s

1. Communicating to concerned officials of all states their concerned Ministers and Secretaries, asking them to direct their respective Municipal Corporations across their state, to ensure Section 8: Glass & Glazing in Part 6 of NBC 2016 is implemented with respect to the usage of safety glasses in buildings by including it in their check list for application for completion or occupancy.

2. Mandating that all bodies i.e. CPWD, AAI, PSU's, NBCC etc. which are directly linked to the Central Government follow the section 8: Glass & Glazing in part 6 of NBC 2016 on safety glass usage.

The Minister patiently heard our concerns and assured us of his support in having the Section: 8 Glass & Glazing in Part 6 of National Building Codes 2016 implemented.

The meeting was highly productive as the Minister issued orders for immediate action on the above.

Training Programme organized by FOSG on BIS certification and incorporation.

FOSG appointed Aleph India QMS on its panel to guide members for getting the BIS certification which is going to be mandatory for all processors from 1st July 2019. To apprise members on the process for getting the BIS certification a training program was organized for Delhi NCR region at Gold Plus office on 17th November 2018, wherein all the members/non members from Delhi NCR region were invited for the event. The training programme was attended by almost all the processor members/non members from Delhi NCR. Mr. Subhash Tyagi, Chairman of Gold Plus Glass Industry Ltd., gave an insight of Glass Industry and its future. Mr. Gurmeet S Singh, Chairman, FOSG gave an insight on FOSG and its upcoming activities. Aleph India represented by Mr. Gurdeep Cheema and Mr. Raghvendra Singh, through presentation briefed members on the process and documentation required for the procurement of the BIS certification.



Besides the above the following presentations were also made for the knowledge enhancement of the members.

- Presentation on procedure for taking BIS certification by Mr. Prem Dutt.
- Presentation on Terms & Conditions of business to print on quotations and invoices with their importance and implications by Mr. Pranit Singh.
- Presentation on Spontaneous breakage in glass by Mr. Samarth Tuteja.
- Presentation on calculating production and post manufacturing costs by Mr. Pranit Singh.
- Presentation on FOSG role in the recovery of bad debt and successful case studies by Mr. Vinod Tandon.

Overall the training programme was a great success and members were of the opinion that FOSG should organize more such training programmes on regular basis for knowledge enhancement.

Vice Chairman, FOSG, North Zone, Mr. Ajay Dhamija, concluded the training programme with special thanks to Gold Plus and Ms. Sheetal Khanna for her co-operation, hospitality and excellent arrangements.
